Terms and Conditions

1. Betul-Betul Free Road Tax ("Campaign") is organised by Polisea Sdn. Bhd. ("PolicyStreet").
2. By participating in this Campaign, the Customer agrees that they have read, understood and accepted these Terms and Conditions and any additional terms set by PolicyStreet, including all decisions related to this Campaign ("Terms and Conditions").

Campaign Period

1. The Campaign will start on 10 October 2024 (10:00 AM) and end on 11 October 2024 (10:00 PM) unless notified otherwise ("Campaign Period").
2. PolicyStreet reserves the right to cancel, terminate, or suspend the Campaign at any time before or during the Campaign Period without prior notice.

Eligibility

1. The Campaign is open to all customers who purchase Motor Insurance Products from the PolicyStreet website ("Customer").
2. Cars with an engine capacity below 1,600cc will qualify for a FREE road tax.

3. Cars with an engine capacity above 1,600cc will qualify for a discount capped at RM90.
4. This Campaign only applies to policies issued by PolicyStreet during the Campaign Period, while policies issued after the Campaign Period are deemed not eligible.
5. The Campaign is limited to the first 5,000 Customers and operates on a first-come, first-served basis.
6. The Campaign excludes road tax for e-hailing vehicles.
7. To qualify for the Bank Instalment or Easy Payment Plan ("EPP"), the Customer shall have a valid credit card from our partnered bank and a minimum purchase of RM500 on PolicyStreet's website.
8. EPP approval is subject to the bank's discretion.

Issuance

1. The Customer shall ensure and guarantee that all details provided are true and/or accurate. PolicyStreet is not responsible for any loss or damage resulting from incorrect or incomplete information provided.
2. The Customer will receive their road tax within ONE (1) working day if purchased during our working hours or by the next working day if purchased outside working hours.
3. The digital road tax will be sent to the email address provided during purchase or renewal.
4. The physical road tax will be delivered by MyEG.

General Terms and Conditions

1. PolicyStreet reserves the right to change, amend, modify, suspend, continue, vary, terminate, and/or add on to all or any parts of the Terms and Conditions of this Campaign at any time without prior notice and without incurring any liability.

2. The Customer agrees to indemnify and keep indemnified against all claims, losses, damages and/or expenses arising from any infringement or violation of any third party's rights concerning the participation in this Campaign.
3. Any cancellation, termination, withdrawal, or suspension of this Campaign by PolicyStreet will not entitle the Customer to any compensation for any loss or damage suffered, directly or indirectly, due to such actions.
4. In the event that the Customer cancels their policy, the full road tax amount will be automatically deducted from the refunded premium amount.
5. Suspected fraudulent activity will be reported to authorities.
